- The Supply and Delivery of Liquid Nitrogen are grouped in lots/Slices. Bidders shall have the option of submitting bids for one, any combination, or all of the lots/slices with the 2.5% bid security of proposed price for the slice or combination of slices. The evaluation and contracts award will be done on slice-by-slice basis that is of least cost to the Purchaser. The Bidder shall have his/her own LN2 Production Factory at specified place or shall submit the proof/assurance letter from third party having own factory to supply the LN2 at specified place and quantity.

The bidder may submit the bid for single or more slices as mentioned in bid document. The evaluation and contracts award will be done on slice-by-slice basis that is of least cost to the Purchaser.

- Pre-bid meeting shall be held at NLBO at 12:00 PM on **17 August, 2022**.
- Bids shall be opened in the presence of bidder's representatives who choose to attend **2:00 PM on 2 September 2022** at the office of **NLBO, Lamapatan, Pokhara**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period i.e., total of 120 days from the day of bid opening.
- If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Deposit Account No.: 3020100102030000** of Treasury and Account Controller office, Kaski (Ko.
