6. Pre-bid meeting shall be held at NLBO at 1:00 PM on **29 February 2020**.
7. Bids shall be opened in the presence of bidder's representatives who choose to attend **1:00 PM on 16 March 2020** at the office of **NLBO, Pokhara**. Bids must be valid for a period of **90 days** counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period i.e. total of 120 days from the day of bid opening.
8. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Deposit Account No.: 3020203000000** of Treasury and Account Controller office, Kaski (Ko. Le. Ni. Ka. Kaski) **at Rastriya Banijya Bank, Pokhara** and submit the receipt of the deposited amount of cash along with the bid.
